**Individual researchers from Brazil and other LAC countries can upload their CVs** on the portal, register their **searches** and **create alerts** to be informed when a vacancy matching their profile has been published.

**Funding organisations**, including from Brazil and other Latin American and Caribbean countries can publish their jobs, funding opportunities and scholarships on the portal – **for free** - to increase their visibility and reach the best candidates worldwide.

To help you identify these opportunities, EURAXESS LAC regularly publishes open calls to fund researchers' mobility and cooperation with European teams. The list combines funding opportunities open to both Brazil and other LAC countries.

The jobs, grants and fellowships announced are **organised by funding organisations (including private ones)**. In section 1, you'll find calls **funded by the European Commission**, in section 2, calls launched by **individual EU member states or associated countries** with or without LAC partners, and in **section 3, calls promoted by LAC institutions**. All of them are open to researchers from at least some Latin America and the Caribbean countries. In section 4, you'll find all the calls that were listed in previous editions of this document and that are **still open**.

We remain at your disposal to discuss any queries you may have regarding your mobility projects.

Established by the European Commission

ERC grants support projects carried out by an individual researcher ("Principal Investigator") who can employ researchers of any nationality as team members. It is also possible to have one or more team members located in a non-European country.

### 1.3 [ERC Advanced Grants \(5 years research projects in Europe, all areas\)](#)

ERC Advanced Grants are long-term funding to pursue ground-breaking high-risk projects. They are designed to support excellent Principal Investigators at the career stage at which they are already established research leaders with a recognised track record of research achievements. This action is open to researchers of any nationality who intend to conduct their research activity in any European Member State or Associated Country.

The ERC's frontier research grants operate on a 'bottom-up' basis without predetermined priorities.

**Eligibility:** any nationality, any age. Applicants must be leaders in their respective field(s) of research and must demonstrate significant achievement in the last 10 years

**Funding:** up to € 2.5 million per grant (up to € 3.5 million in some cases)

**Duration:** up to 5 years

**Sole evaluation criterion:** scientific excellence of researcher and research proposal

**Deadline:** 30 August 2018. For more details on Advanced grants, see [ERC website](#)

### 1.4 European University institute (EUI, Italy) – incoming fellowships in social sciences and humanities

#### 1.4.1 [Fernand Braudel Senior Fellowship](#)

Fellowships last for up to ten months in one of the EUI's four Departments which in turn invite fellows to participate in departmental activities (seminars, workshops, colloquia, etc.).

Fellows are encouraged to make contact with researchers sharing their academic interests, may be involved in the teaching and thesis supervision tasks of EUI professors, and associated with one of the research projects being carried out at the EUI.

Departments with open calls for the current call:

- Department of Economics
- Department of History and Civilization

**Deadline:** 30 September 2018

#### 1.4.2 [Max Weber Fellowships for junior post-docs](#)

Max Weber fellowships are designed for junior post-docs who would like to pursue an academic career, concentrate on their own research and enhance their academic practice in a multidisciplinary environment. The Programme awards 1, 2, and exceptionally 3 year-long fellowships in the fields of political and social sciences, economics, law and history.

## 1 European Union

### 1.1 [Many Horizon 2020 calls of interest or specifically targeting Brazil or Latin America to open](#)

#### International cooperation

**ALL H2020 calls are open to international and more specifically Brazilian and other Latin American and Caribbean participation.**

For more details on funding of applicants from non-EU countries, click [here](#).

The **last calls** of the Work Programme 2018-2020 of Horizonte 2020, were published on 2 July 2019.

The EU Delegation to Brazil kindly compiled a list of **indicative calls with international cooperation as priority**. These particular calls are specifically **open or focusing on collaboration with the Latin American region or specific countries of the region, like Brazil and Mexico**.

[Horizon 2020](#) is the EU funding **programme** for research and innovation running from 2014 to 2020 with a €80 billion budget. **H2020** supports scientifically-excellent research, innovation, and technological development, through [collaborative and innovative research projects as well as grants and fellowships to individuals](#) set out in the Horizon 2020 work programme. The vast majority of this funding is allocated on the basis of **competitive calls open to applications from researchers, businesses and other interested organisations** located in any of the EU Member States or countries [associated](#) to Horizon 2020.

Horizon 2020 is also open to the world, so **Brazilian and LAC researchers and institutions** are very welcome to get involved.

The [final Work Programme for Horizon 2020](#) (2018-2020) covers the budgetary years 2018, 2019 and 2020, representing an investment of around €30 billion.

Access all open calls on the [Horizon 2020 Funding & tender opportunities Portal](#). One can filter by keyword, programme part, focus area, cross-cutting priority.

**Organisations from any sector and country, including LAC countries** can participate in H2020 projects.

**Only organisations from the Bahamas, Barbados, Brazil, Mexico and Trinidad and Tobago** are not eligible for direct automatic funding by the European Commission, unless clearly stated in the call. It is suggested that Brazilian and Mexican organisations check their local co-funding schemes to support their participation ([here](#) for Brazil, and [here](#) for Mexico).

**Please, note that all Latin American and Caribbean individual researchers, including Brazilian and Mexican, are eligible to funding by MSCA and ERC.**



## 1.2 Marie Skłodowska-Curie Actions – Open call to select [Innovative training networks \(ITN\)](#)

**Innovative Training Networks (ITN)** is the **main European doctoral training programme**, putting a special emphasis on non-academic sector participation and the innovation dimension. Innovative training networks bring together **complementary institutions from different countries worldwide** to train a new generation of researchers.

It is funded under the [Marie Skłodowska-Curie actions/ Horizon2020 European Union funding programme](#).

The call is **open to consortia of organisations** such as universities, research centres or companies, that propose a research training network, including **Brazilian & Latin American institutions**.

**There are three types of Innovative Training Networks:**

### 1. **European Training Networks (ETN)**

Joint research training, implemented by at least three partners from in and outside academia. The aim is for the researcher to experience different sectors and develop their transferable skills by working on joint research projects.

The organisations should be established in at least three different [EU or associated countries](#). Additional participants from any organisation anywhere in the world, **including Brazil & LAC** can also join a network.

### 2. **European Industrial Doctorates (EID)**

Joint doctoral training delivered by at least one academic partner entitled to award doctoral degrees, and at least one partner from outside academia, primarily enterprise. Each participating researcher is enrolled in a doctoral programme and is jointly supervised by supervisors from the academic and non-academic sector, where they spend at least 50% of their time.

The aim is for the doctoral candidates to develop skills inside and outside academia that respond to public and private sector needs.

The organisations should be established in at least two different [EU or associated countries](#). A wider set of partner organisations from anywhere in the world may also complement the training.

### 3. **European Joint Doctorates (EJD):**

A minimum of three academic organisations form a network with the aim of delivering joint, double or multiple degrees. Joint supervision of the research fellow and a joint governance structure are mandatory. The aim is to promote international, intersectoral and multi/interdisciplinary collaboration in doctoral training in Europe.

The organisations should be from different [EU or associated countries](#). The participation of additional organisations from anywhere in the world, including from the non-academic sector, is encouraged.

The maximum duration of an ITN project is **four years**. Calls are annual.



**European Research Council**

Established by the European Commission

The [European Research Council](#) is the first pan-European funding organization for frontier research. It aims to stimulate scientific excellence in Europe by encouraging competition for funding between the very best, creative researchers of any nationality and age.

**Brazil and ERC:**

To date, **nine Brazilian researchers have been awarded ERC Starting, Consolidator and Advanced Grants.** They are: The Fields medallist [Artur Avila](#) for his Quasiperiodic project; [Aureo de Paula](#) for his project on “Econometric Analysis of Interaction Models”; [Elison Matioli](#) for his project IN-NEED on energy efficiency; [Bernardo Franklin](#) for his Plat-IL-1 project on inflammasomes; [Eduardo Lee](#) for his project TOPOQDot on topological materials; [Roberto Rinaldi](#) for his LIGNINFIRST project on lignocellulosic Biomass; [Mariana de Campos Françoze](#), for her BRASILIAE project on Indigenous knowledge; [Aline Vidotto](#), for her ASTROFLOW project on the influence of stellar outflows on exoplanetary mass loss; and [Mario Barbatti](#), for his project SUBNANO on Computational Photochemistry.

**1.3 European Research Council ([ERC](#)) - [Starting Grants call 2020](#)**

European Research Council's (ERC) Starting Grants are designed to support excellent Principal Investigators at the career stage at which they are **starting their own independent research team or programme in all scientific fields.**

**ERC Starting Grants in brief:**

- For researchers of **any nationality** with **2-7 years of experience** since completion of PhD (or equivalent degree) and scientific track record showing great promise
- **Research must be conducted in a public or private research organisation** located in one of the EU [Member States](#) or [Associated Countries](#) (including Norway, Switzerland)
- Funding per grant: **up to € 1.5 million**. An additional € 0.5 million can be made available to cover eligible “start-up” costs for researchers moving from a third country to the EU or to an associated country and/or the purchase of major equipment and/or access to large facilities.
- Duration: **up to 5 years**
- Sole evaluation criterion: scientific excellence of researcher and research proposal
- Calls for proposals: published once a year

Deadline: **16 October 2019.**

**ERC open to the world**

The ERC strives to attract top researchers from anywhere in the world to come to Europe. To date, the ERC has funded some 9.000 top researchers at various stages of their careers.

Currently, there are **730 principal investigators of non-ERA nationality**, representing 8% of all grantees. To date, **46** are nationals from LAC. They come from Argentina (**18**), Brazil (**9**), Mexico (**5**), Chile (**3**), Colombia (**2**), Venezuela (**2**), Costa Rica (**2**), Bolivia, Ecuador, Jamaica, Panama and Peru (**1** each). **51 nationalities among winners of 2019 ERC Starting Grants**

In the call 2019, researchers from 8 Latin American countries (**Argentina, Brazil, Chile, Colombia, Costa Rica, Cuba, Mexico and Peru**) were awarded an ERC Starting Grant.

The results of this grant competition show a greater diversity of nationalities than ever before: researchers are from 51 different countries of origin across the world

**1.4 [ERC Synergy Grants](#)**

WHAT? European Research Council ERC Synergy Grants are designed to tackle truly bold scientific challenges by funding **groups of up to 4 excellent PIs** who jointly address the frontier of knowledge.

WHO? This action is open to **researchers of any nationality** with early achievement or a 10-year track-record who intend to conduct their research activity in any Member State or Associated Country.

Please, note that as from July 2018, Synergy Grant Group can include up to one Principal Investigator based in a third country, including in Brazil and other LAC countries.

The ERC's frontier research grants operate on a 'bottom-up' basis without predetermined priorities.

### **ERC Synergy Grants in brief:**

- Fund a small group of PIs (2 to 4) with a designated corresponding PI who applies.
- Research projects must tackle ambitious scientific challenges through a unique combination of skills and knowledge of the PIs. Applications must demonstrate that the proposed research cannot be carried out by a single PI working alone.
- Any field of research.
- For researchers of **any nationality** presenting an early achievement track-record or a ten-year track-record
- **Research must be conducted** by all PIs in **public or private research organisation(s)** located in one of the EU [Member States](#) or [Associated Countries](#) (including Norway & Switzerland). One PI can be based outside of EU or AC. PIs can apply within the same host institution (HI) or through different HIs.
- Each of the PIs shall spend a minimum of 50% of their total working time in an EU Member State or Associated Country (except the one located out of Europe, if any), and a minimum of 30% of their total working time on the ERC project.
- Funding per grant: **up to EUR 10 million** (in some circumstances up to EUR 14 million)
- Duration: **up to 6 years**
- Sole evaluation criterion: scientific excellence of the proposal
- Calls for proposals: published once a year

Deadline: **5 November 2019**.

Please, note that ERC grants support projects carried out by an individual researcher ("Principal Investigator") in the case of Starting Grants, or 2 to 4 individual researchers (under Synergy Grants) who can **employ researchers of any nationality as team members**. ## 1.5 European Molecular Biology Laboratory (EMBL) – [International PhD programme](#)

The EMBL International **PhD Programme is Europe's 'best in class' PhD programme for the Life Sciences**. It represents the flagship of EMBL's commitment to first class training and education. Internationality, dedicated mentoring and early independence in research characterise our programme.

[BiodivERsA](#) is a network of **39 organisations from 24 European countries** programming and funding excellent research in the field of biodiversity, ecosystem services and Nature-based Solutions.

**The following Brazilian States will participate in the call**, with the support of CONFAP: Alagoas, Amazonas, Bahia, Distrito Federal, Espírito Santo, Goiás, Maranhão, Mato Grosso, Mato Grosso do Sul, Minas Gerais, Paraíba, Paraná, Pernambuco, Rio de Janeiro, Rio Grande do Sul, Santa Catarina e São Paulo.

Research teams will be invited to form transnational research consortia with **eligible partners from minimum 3 countries participating in the call** (including minimum two from EU Member States or EU Associated Countries). The call aims to support **transnational research projects** jointly addressing issues at the interface between biodiversity and climate change, and across a range of spatial and temporal scales in order to advance knowledge and support evidence-based and reflected decision-making. Projects addressing only biodiversity issues or only climate change issues will not be considered within the scope of the call.

The maximum project duration is 3 years.

This call will cover the following **four non-exclusive themes**:

- Consequences of climate change on biodiversity and nature's contributions to people
- Climate-biodiversity feedback processes
- Potential of nature-based solutions for mitigating and adapting to climate change
- Synergies and trade-offs between policies on biodiversity, climate and other relevant sectors, and the role of agents of change

Nevertheless, before starting the grant, a proof of the PhD degree will be requested. Not only researchers from academic institutions can apply, but also scientists working in industry.

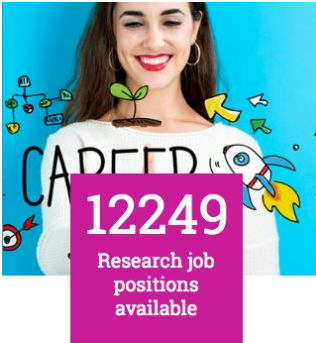

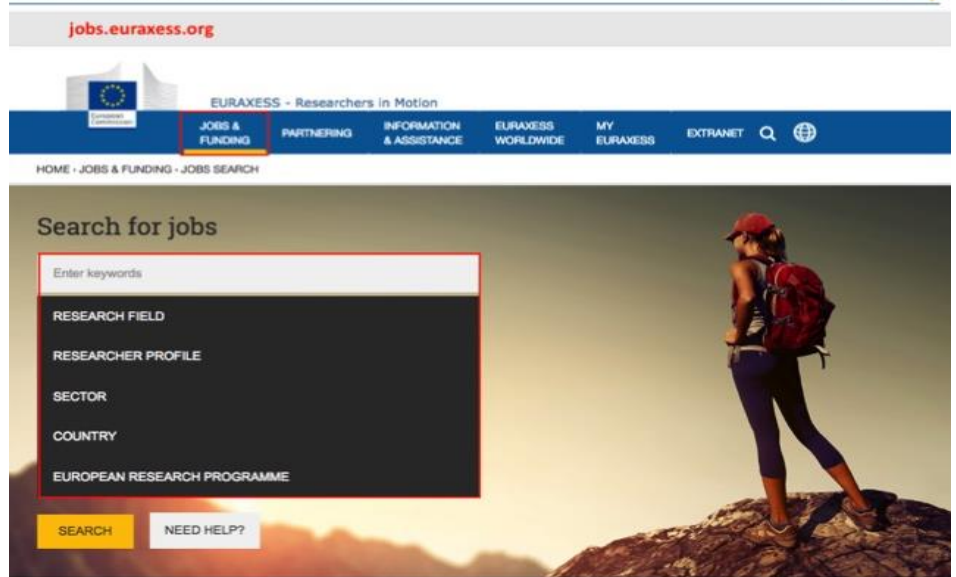

The overall goal of the **RE**inforcing **W**omen In **RE**search (**REWIRE**) COFUND Programme, a Marie Skłodowska Curie Actions COFUND project funded by the European Commission, is to establish a support scheme for excellent postdoctoral female researchers to foster their scientific development, to nurture their expertise and to make a profound impact on their future careers.

## 2.4 BELGIUM (WBI) - [Incoming and outgoing doctoral and postdoctoral scholarships for Excellence IN.WBI & WBI.World](#)



Two schemes are receiving candidacies under the programme:

### 1. IN WBI Excellence Scholarship Program (Incoming to Belgium)

Who? Open to foreigners from any nationality, including Brazilians and other LAC nationalities, wishing to enrol in a post-doctorate programme in a University of Wallonia-Brussels in the following fields:

- Transport and logistics;
- Mechanical engineering;
- Life sciences;
- Agriculture-industry;
- Aero-space;
- Environmental technologies.

Other fields may be considered, including human sciences, and fundamental or applied research.

Types of programme: Long-term scholarships (minimum 1 year, renewable once) at postdoctoral level; Short-term scholarships (1 to 3 months, non-renewable) at postdoctoral level.

For long-term scholarships: No later than the 1st of March preceding the academic year during which the stay is requested (starting 1 October at the latest).

For short-term scholarships: depends on the expected dates of the research stay.

### 2. WBI.World Scholarship Program (Outgoing from Belgium)

Fellowships are also available for **Belgian or resident students in the same fields as mentioned above** to follow a **doctorate or postdoctorate programme** in a university abroad.

Deadline depends on the expected dates of the research stay.





## 2.5 BELGIUM (ULB) – [Postdoctoral fellowships in all research fields](#) (IF@ULB)



IF@ULB is a European postdoctoral programme, COFUNDED by the Université libre de Bruxelles and the European Commission within the framework of Marie Skłodowska-Curie actions (H2020).

The programme will enable ULB to recruit 63 international postdoctoral researchers between 2018 and 2023, in three calls. **At each call, IF@ULB will offer 21 positions** in one of the ULB research centres. The positions are open to researchers in **all fields**, according to a bottom up approach. The evaluation procedure will be organised through three panels: **Social Sciences and Humanities, Physical and Engineering Sciences, Life Sciences**.

**Each fellowship will be granted for 2 years.** All positions will receive fellow-related and research-related funding.

### WHO?

- Applicants of **any age and of any nationality** are eligible.
- Eligible applicants are Experienced Researchers, i.e.
  - Holders of a PhD degree obtained max. 7 years before the call deadline.
  - Applicants without a PhD, provided they have documented full-time equivalent research experience of minimum 4 and maximum 11 years prior to the call deadline.
  - An eligibility extension of 15 weeks per child is granted in case of maternity
- Eligible applicants must not have resided or carried out their main activity (work, studies, etc.) in Belgium for more than 12 months during the 3 years preceding the call deadline.
- There are no restrictions on scientific domain. A member of ULB academic staff must explicitly accept to supervise and train the applicant to integrate them in their group.

Deadline: **1 October 2019**.

## 2.6 BELGIUM (FNRS) – BRAZIL (Fapesp) – [call for bilateral projects](#)

Call for bilateral basic research projects of up to 2 year duration in

- Natural and Life Sciences;
- Engineering;
- Social Sciences; and
- The Humanities.

FAPESP will assume the funding of research teams from the State of São Paulo and F.R.S.- FNRS will assume the funding of research teams from Belgium, in all cases according to their national rules and regulations and budget availability.

This call is open to researchers, starting at the postdoctoral level, affiliated to the French speaking higher education universities/colleges, or research institutions of the FWB. On Brazil side, the call is detailed under SPRINT call for proposals 3/2019 (see below).

## 2.7 DENMARK – [PhD positions at the Faculty of Science, University of Copenhagen](#) (TALENT)

TALENT IS co-funded by the European Union's Horizon 2020 research and innovation programme under the Marie Skłodowska-Curie Actions.

Research at the Faculty of Science at the University of Copenhagen rests on two pillars: on the one hand strong basic research, and on the other application-oriented research, which contributes to growth and employment and solves societal problems, for example within climate change, sustainable energy supplies, biological production, environmental challenges, food and water safety, lifestyle diseases and IT security.

**25 PhD fellowships** are in the following fields: Biodiversity; biological sciences and bioinformatics; chemical sciences; computer sciences; earth and planetary systems sciences; environment, climate and sustainability; food sciences; health and genomics; mathematical sciences, statistics & economics; nano and materials sciences; natural science education; nutrition and sports; particle physics, astro physics and cosmology; plant sciences and biotechnology; quantum sciences and technology; resource economics and global development.

Applicants **must hold a relevant MSc degree at the time of applying**. However, candidates, who do not hold an MSc degree, are also considered eligible **if their credentials and CV equal those achieved on an MSc**. This could be in the form of five years of full-time undergraduate and postgraduate education **OR** four years of full-time undergraduate education combined with relevant courses, fieldwork, scientific publications or conducted research (**these aspects must be documented by uploading additional documents as part of the CV**).

## 2.8 FINLAND – [Funding for research post as Postdoctoral Researcher in Finland, all research fields](#)

The aim of the funding for research posts as Postdoctoral Researcher is to support the most talented researchers who have **recently completed their doctoral degree** in gaining competence for demanding researcher or expert positions. Mobility since completing their doctorate is required of the applicant. In the review of applications, particular attention will be paid to the international dimension of the research plan. The funding is meant for the applicant's own salary and personal research expenses.

**WHO?** To be eligible to apply, you must be a researcher with **up to four years of experience since PhD completion** (degree certificate issued 25 Sep 2015–25 Sep 2019), or up to eight years if you have obtained the degree simultaneously with medical specialist training.

Applicants who have completed their doctoral degree more than four years ago can be considered only for special reasons (maternity, paternity, parental or childcare leave, military service or nonmilitary service, or long-term illness).

Deadline: **25 September 2019**.

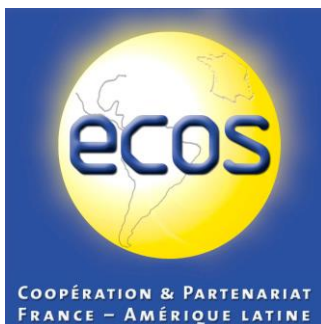

ECOS Nord is a bilateral cooperation program between France and certain Latin American countries, including Mexico, Colombia and Venezuela, located at the University of Paris 13. This year, an agreement was signed between the French government and the Peruvian government "for the development of joint activities in science, technology and research". This agreement is materialized by the creation of the ECOS Nord Pérou program through calls for applications funding researcher mobility in both countries over a three-year period.



## 2.11 FRANCE (L'Oréal) – Peru (CONCYTEC-FONDECYT-ANC) [For Women in Science Award](#) 2019

This edition considers young scientific researchers who have been conducting research in the scientific disciplines of **Life Sciences, Basic Sciences (Mathematics, Physics and Chemistry), Engineering and Archaeology**.

### Objective

The National Prize "For Women in Science" is a recognition to the Peruvian woman researcher who emphasizes the excellence of the woman in the scientific task and stimulates the scientists of talent so that they continue with their works of investigation with the dynamism and the passion that characterize them.

### Priorities areas of the call:

- Life Sciences
- Basic Sciences (Mathematics, Physics and Chemistry)
- Engineering
- Archaeology

### Eligibility:

#### Category A

**Women of Peruvian nationality** who reside in the country, with an academic degree of doctorate and who, throughout their scientific trajectory, have contributed with significant contributions to scientific knowledge and/or technological development.

#### Category B

**Young researchers of Peruvian nationality residing in the country, no older than 38 years old** and who find themselves with research linked to any of the scientific disciplines indicated in this call.

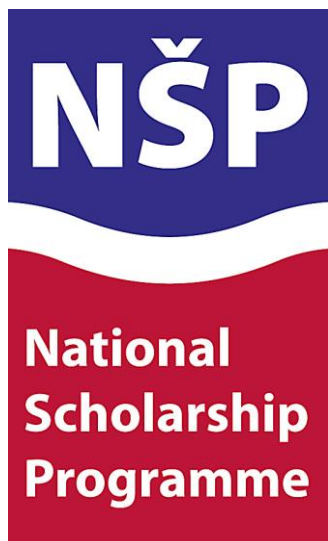
## 2.28 SLOVAKIA – [National Incoming and Outgoing Scholarships](#)

If a PRIMA grantee is appointed as a professor in Switzerland during the funding period, the remaining amount of the PRIMA grant will be transferred to the new place of work as research funds.

- Researchers:
  - have a **doctorate** (PhD) or at least three years of research activity after obtaining their higher education degree (equivalent qualification to a doctorate).
  - have acquired at least **two years of research experience** after their doctorate or equivalent qualification to a doctorate.
  - submit their application **between two and ten years** after their PhD defense or after the date of the equivalent qualification to a doctorate.
- Clinical scientists:
  - have a medical exam (state examination or equivalent).
  - have acquired at least three years of clinical work and at least 2 years of research activities after their medical exam.
  - submit their application up to 14 years after their medical exam.

The time periods are calculated on the basis of the relevant submission deadline for PRIMA applications.

## 2.40 SWITZERLAND (University of Basel) - [Biozentrum PhD Fellowships Programme](#)
