### Invitation for Expression of Interest:

#### PhD Fellowship “Production and characterization of realistic atmospheric aerosol for health studies”

The Institute of Chemical Engineering Sciences, Foundation of Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for one PhD fellowship in the context of the research project “Impact of Exposome on the Course of Lung Diseases (REMEDIA)”, which is implemented under the H2020 Research and Innovation Action.

#### Job Description

To conduct research in the framework of the aforementioned project "REMEDIA". The main objective of REMEDIA is to investigate the effect of the exposome and especially air quality on the course of lung diseases. The objective of this job is to develop and test a mobile atmospheric simulation system to produce realistic aerosol for the REMEDIA studies.

**Duration:** 12 months, with the potential of renewal

**Salary:** 840 Euros per month (total cost of the employer, including social security and taxes)
