The evaluation of candidates will be conducted in accordance with the UW Statutes, the recommendations of the European Charter for Researchers. Requirements for the candidate, qualifications

- 1. A doctoral degree (in sociology or similar disciplines, i.e. communication and media studies) or obtain a doctoral degree before 1 October 2024 (a formal requirement).
- 2. Scientific track record, especially publication record: articles in journals, books, chapters in reviewed volumes.
- 3. Research and analysis competences: an in-depth knowledge of new theoretical and methodological approaches in researching digital society.
- 4. The Candidate assessment will also consider teaching experience (leading academic courses, organization of workshops, trainings), especially teaching practical, workshop-based classes using qualitative data and contemporary methods of analysis of thereof.
- 5. Organizational experience, such as: (co)organizing conferences, conference sessions, institutional engagement; taking part in actions outside of the area of academia, i.e. NGOs, and expert activity.
- 6. Very good working knowledge of Polish and English, allowing for the writing of scientific publications and teaching academic courses (a necessary condition).

Description (topics, expectations, comments)

We are looking for a researcher with at least a doctoral degree, specializing in the theory and methodology of digital sociology, especially in using and developing new methods of qualitative data analysis (including computer-assisted content analysis). The candidate should be very well-versed in new theoretical approaches in digital sociology, especially in critical data analysis, datafication and algorithmization, as well as new approaches to technology and society research. We are expecting readiness to develop skills in the area of the newest methods of digital sociology methods (i.e. situational or thematic analysis, network analysis or qualitative content analysis).

We are also expecting experience in conducting analyses in the above areas, confirmed by publication track record, as well as the readiness to lead courses dedicated to these issues, especially workshop-based practical courses, aimed at providing the students with practical skills in applying digital methods to researching contemporary society.

The expectations towards the assistant professor (research and teaching) include research and publication output, especially publishing in international-range journals, acquiring research grants from country and international institutions, as well as an active engagement in scientific life of the Faculty of Sociology: organizing and attending seminars and other scientific events. The teaching duties will include teaching courses and advising the graduate theses of the students, especially for Bachelors and Masters students. The specific scope of the courses will depend on the Faculty's and University's teaching needs. The employment is also connected with organizational work for the Faculty and the University.

Basic responsibilities

- 1. The main research field and discipline: social sciences, sociological sciences.
- 2. Research duties: conducting scientific research, taking part in research projects, leading research projects, acquiring funding for research projects, publishing the research output in journals and monographs, perfecting of the research capabilities.
- 3. Teaching duties: leading academic courses in Polish and in English, perfecting the teaching skills, advising on BA and MA theses.
- 4. Organizational duties: organizing conferences, seminars, workshops, participating in chosen chair/center at the Faculty, as well as organizational bodies of the Faculty and the discipline of Sociology at the University of Warsaw, and their committees.

The project should include (1) general description of the course, including the title, a thematic overview (one paragraph) and the plan of the course meetings, a short list of proposed literature, materials, sources of software, a description of the learning outcomes (especially the skills that would be acquired by the students), proposed teaching methods, especially in engaging the students and veryfing their knowledge, and (2) a plan of one chosen class meeting. The course project will be discussed during the interview.
