- e) **Specialization Certificates Copies:** Original certificates or diplomas that attest to any completed specializations. The originals are required for verification purposes. - The maximum possible score for each candidate is 100 points, and the minimum passing score is 60 points.
- The candidates' interview scores will be the arithmetic average of the scores given by the committee members.
