International cooperation opportunities in Cluster 6





- The Communication of 18 May 2021 on the Global Approach to Research and Innovation defines the "Europe's strategy for international cooperation in a changing world"
- Cooperation with other countries is crucial to address **sustainability challenges** which are by definition global. International cooperation in Cluster 6 corresponds to strategic policy objectives with **EU international partners**.
- In Cluster 6 multilateral as well as bilateral approaches are supported.
- The first HE WP has just been adopted. Already in 2021 Cluster 6 calls, 32 topics expressly encourage international cooperation and have therefore been flagged for the EC policy priority 2019-2024 "A stronger Europe in the world" and more will follow in 2022.
- 3 topics explicitly mention the relevance of cooperation with Brazil/Latin America (topics with identifiers in blue)
